### **Private Nuisance - FindLaw**

A private nuisance is a tort whereby the tortfeasor unreasonably interferes with the use or enjoyment of the land of another individual person or party. When the nuisance is private, it affects an individual or small group of individuals - as opposed to a public nuisance which affects more than one person such as the public at large.

Private Nuisance Definition: A public nuisance is an unreasonable interference with a right common to the general public..." " [A] private nuisance is a nontrespassory invasion of another's interest in the private use and enjoyment of land. "Unlike a public nuisance, a private nuisance threatens only one or few persons.

A nuisance (sometimes called a private nuisance to distinguish it from a public nuisance, which is a completely different subject) is an interference with the right to use and enjoy real property. Physical invasions onto the property are trespasses, so a nuisance can be called a nontrespassory interference with the use of real property.
